

**HUMBLE PRAYER AND PETITION  
TO HER EXCELLENCY**

MAY IT PLEASE YOUR EXCELLENCY. It is my duty to keep you informed as to my will on any matter that comes before the Parliament or that should come before the Parliament.

The Department of Health is in breach of our Commonwealth Constitution in relation to the enforced toxic fluoridation of our public water supply with industrial fluoride.

This breach of the Commonwealth Constitution is in regard to Chapter 1, Part V. - Powers of the Parliament, section 51 (xxiiiA) where it states " Medical and dental services are provided but not so as to authorize any form of civil conscription." The enforced toxic fluoridation of the public water supply is civil conscription. Water fluoridation is also in breach of the Nuremberg Code to which Australia is a signatory.

No official referendum has been held on the enforced toxic fluoridation of the public water supply anywhere in Australia. Therefore any Government may face future litigation in regard to water fluoridation.

Face to face Community consultation has not been forthcoming in most areas, even when repeatedly requested.

The enforced toxic fluoridation of the public water supply with industrial fluoride is mass medication and is a gross loss of freedom of choice in a free country.

HEALTH ISSUES OF THE INDIVIDUAL ARE NOT TAKEN INTO ACCOUNT.

**Many adverse scientific findings are being ignored, such as:**

A Scientific Review of EPA's Standards.

**Total fluoride intake is not measured:**

In 1994 the World Health Organization (WHO) warned that a total fluoride intake study should be conducted prior to the fluoridation of the public drinking water. This warning is being ignored.

Dental fluorosis (from fluoride overdose) is found to affect 45% of children in toxic industrial-fluoridated areas.

On 12/8/1987, as recorded in Hansard, Mr Harley Rivers Dickinson, read the Dickinson Report to the Commonwealth Parliament making Parliament aware of the dangers of water fluoridation (both physical and mental).

Industrial fluorides are not the same as the naturally occurring calcium fluoride which is virtually free of heavy metals and arsenic.

Therefore:

IT IS MY WILL: that all water fluoridation in Australia be stopped and remain stopped until such time as there is a full, independent, comprehensive Scientific Review on the impact toxic industrial fluoridation of the public water supply has on human health.

IT IS MY WILL: that such Scientific Review be conducted by an independent body followed by the release of all scientific and medical findings to the public.

IT IS MY WILL: that fluoride be made available to the public by other means that do not violate the individuals' right to choose their own medication or breach our Commonwealth Constitution.

I do most humbly and respectfully Pray and Beseech Your Excellency to convey MY WILL to the State Parliament.
